As a condition of attendance, in-person delegates must agree to adhere to all Covid-safe measures put in place by ACD ASM 2025 and/or ADNA Conference 2025, the venue, federal or state guidelines and acknowledge that these procedures may be changed at any time in accordance with the latest health advice from the Australian Government.

ACD ASM 2025 and/or ADNA Conference 2025 and Think Business Events (ASM/Conference Organiser) reserve the right to publish changes to these Terms and Conditions at any time without prior notice.

# **PAYMENT OF REGISTRATION**

The payment of the registration is either by credit card or bank deposit at the time of registration. After 9th May 2025 midnight AEST, only payment made by credit card will be accepted. A registration is considered complete when full payment is received by the ASM/Conference Organiser. The Australian goods and services tax (GST) at 10% is applicable to all goods and services offered by the ACD ASM 2025 and/or ADNA Conference 2025. All registration fees listed include GST.

# Early Bird registration fees

To qualify for early bird registration, registration fees must be paid in full by 20 March 2025. If registration fees have not been received by 20 March 2025 your registration will revert to the standard ASM registration fee.

Registration fees are based on date of payment receipt, not the date of receipt of registration form.

# **Member Registration**

# **Day Registration**

Delegates can only purchase ONE day registration. If more than one day registration is required, then a FULL registration must be purchased.

# **Full-Time Student Registration**

The Student Rate applies to those who are a full-time student at the time of registration or have a student card valid in 2025. Students are those studying in an entry-level education University program. A valid document, i.e., student card or letters issued by the school/university/institution must accompany the student registration.

# LATE REGISTRATION

The ASM/Conference Organiser cannot guarantee the availability of collateral, such as satchels or social function tickets such as the Conferring Ceremony (Graduation and Awards Ceremony) and "Founder's Reception" and/or the College Party to Delegates who register late (inside four weeks before the ASM starts) as there is a risk that social program functions may be fully subscribed. These tickets will be forfeited and the ASM registration fees will not be discounted.

# TRANSFER OF REGISTRATION

All fully paid registrations are transferable to other persons from the same organisation. Details must include the full name of the replacement person, their title, contact phone number and email address. All other registration details will be carried over to the new person unless otherwise specified.

Transfer of registrations to another person will include the registration, all associated social event tickets (including additional purchases).

Should the new Delegate not require an item previously booked by the original Delegate, the cancellation and refund policy for the item cancelled will apply.

Registrations are individual and cannot be shared.

## **NON-ATTENDANCE/NO-SHOWS**

No refund will be made for non-attendance at the ASM or social events.

# CANCELLATION OF THE REGISTRATION BY THE DELEGATE

All cancellations must be made in writing to the ASM/Conference Organiser at acdasm@thinkbusinessevents.com.au.

**Full ASM or one-day-only cancellations:** If you have registered for the ASM as a full or a day Delegate, whether on-demand or in-person:

You are entitled to a refund if the cancellation is received on or before 2 May 2025. However, you will incur a \$150 administrative fee.

You are not entitled to a refund of the registration fees if the cancellation is received after 2 May 2025.

**Part cancellation:** If you would like to cancel part of your registration package (e.g. Additional social event tickets):

You are entitled to be refunded the fee that is applicable to the cancelled part of the package, if the cancellation is received on or before 2 May 2025. However, you will incur a \$25 administration fee. You are not entitled to any refund of the registration fee if the cancellation is received after 2 May 2025.

**Final date to claim a refund:** To claim applicable refunds for cancellations or alterations, please email <u>acdasm@thinkbusinessevents.com.au</u> on or before 2 May 2025. No refunds (in part or in full) will be accepted after this date, but you may choose to transfer your registration to another person within your organisation if permitted under these Terms and Conditions.

**Processing time for refunds:** Refunds (less applicable administrative fees) will be processed no later than 30 days after the conclusion of the ASM.

If your application for a visa to enter Australia is unsuccessful, the above cancellation terms apply.

# CHANGE OF THE IN-PERSON REGISTRATION TO AN ON-DEMAND REGISTRATION

#### At the Delegate's request due to government restrictions

If a Delegate is unable to travel to ACD ASM 2025 and/or ADNA Conference 2025 to attend the ASM in-person due to government restrictions on travel as a result of the COVID-19 pandemic, the Delegate's registration will be converted to an on-demand only registration upon written request to the ASM/Conference Organiser.

# At the Delegate's request for other reasons

If a Delegate would like to convert their in-person registration to an on-demand registration for personal reasons not related to government restrictions on travel as a result of the COVID-19 pandemic the request must be received in writing at <a href="mailto:acdasm@thinkbusinessevents.com.au">acdasm@thinkbusinessevents.com.au</a> no later than 2 May 2025. # Change of the in-person ASM to an ON-DEMAND/VIRTUAL only ASM by ACDASM 2025 or THINK BUSINESS EVENTS

In the event the in-person ASM cannot go ahead due government restrictions on travel or gatherings, the ASM may be delivered fully online via a virtual platform.

A fully virtual ASM means the ASM will not be broadcast from Brisbane and all Delegates, Speakers, Sponsors and Exhibitors will be attending the ASM virtually.

All in-person registrations will be converted to virtual registrations.

# Cancellation, postponement or change of registration of the ASM by ACD ASM 2025 and/or ADNA Conference 2025 or THE ASM ORGANISER

It may be necessary for reasons beyond the control of ACD ASM 2025 and/or ADNA Conference 2025 or the ASM/Conference Organiser to alter the times, dates, itineraries or Speakers of the ASM by notice to you at any time.

In the event of cancellation or postponement of the ASM, or if the registration is converted from an in-person registration to a virtual-only registration (or vice versa), due to circumstances beyond ACD ASM 2025 and/or ADNA Conference 2025 or the ASM/Conference Organiser reasonable control including but not limited to acts of terrorism, war, acts of God, natural disaster or global health crises (including any government restrictions on travel or gatherings), ACD ASM 2025 and/or ADNA Conference 2025 or the ASM/Conference Organiser cannot be held responsible for any cost, damage or expense which may be incurred by Delegates as a consequence of such cancellation, postpone or change.
